PRESIDENT'S CORNER: *At It Again...*

The legislative session is in full swing and I've become one of the regulars at public hearings. The public-private partnership is a battle we have to wage on multiple fronts, both beyond and within the walls of UConn Health.

Beyond our walls, we have elected officials who are considering proposals to make it easier to privatize government programs (or at least some aspects of them). What I've been trying to remind these decision makers – who work for us, remember, we elected them – is that our work serves some of the most vulnerable populations, and that work is not always profitable. Partnering with a private entity very well could make some economic sense, but economics isn't – and never should be – the top priority of the work we do. There's too much talk of numbers and not enough talk about people.

Within our walls – and this is the sad part – we need to prepare ourselves for the possibility that our goals and the goals of University leadership may have much less in common than we've been told. For now I'll leave it at that and hope I'm wrong.

In the meantime, what we can control is what we say to elected officials, friends, family, visitors, patients, each other – anyone who'll listen. Our message is a public hospital for the public good. Emphasize the importance of the work you do and how it makes a difference even if it doesn't make a profit.

When management requires you to attend any type of meeting, whether it be a staff meeting, training or an individual meeting, it must be during your work hours. You cannot be mandated or emergency staffed to attend a meeting.

If you volunteer to attend any of the above, you do not punch out until after the meeting. If you come in earlier than your shift or on your day off, be sure to punch in when you arrive and out when you leave. You will be compensated at time-and-a-half if you have worked over 8 hours (12 hours for 12-hour shift staff) in a day or 40 in a week.

Work is your priority during your scheduled FTEs. The rest of the time is yours to spend as YOU wish.
