




No Election Needed

PRESIDENT'S CORNER

It's Time (Again) To Be Heard

Much has been going on this past month.

First, on the clinical ladder issue, we presented at a Step 2 grievance hearing. We believe we put on a strong case. We are waiting to hear back from the hearing officer for results, but this feels like it's on the fast track to arbitration.

I've had four trips up to the Capitol this month, speaking with Public Health Committee Chairs, and Senate and House leadership. Each time we spoke about our stake in this privatization fight. For those who missed it we also had five elected officials come to our meeting Jan. 30 (bit.ly/20membmtg).

We spoke – and not just me, rank and file members. They listened, then they spoke, and for me, Sen. Greg Haddad had one of the most important messages:

“We are committed to maintaining UConn Health as THE public hospital in Connecticut.”

Our next big opportunity is **Feb. 18**, when there will be a public hearing at the LOB (Legislative Office Building). We will be trying to turn out people from all of the different unions here at UConn Health. UHP needs to be out in full force. We need to lead this fight. If you are uncomfortable speaking, write testimony and have it submitted into the record. Be a voice in protecting our hospital and the patients we serve here.

STEWARD TIP: Proceed With Caution

Information and technology are very powerful tools today. Most people have one, if not several, personal electronic devices that we use to communicate and provide ourselves with information. The danger is where and when we use these tools.



The workplace is not a place where our personal devices should be seen or used. UConn Health is your workplace. While you are working it is totally inappropriate to be texting, taking photos, shooting videos, or posting to social media sites. If you are engaging in this behavior you are placing your employment in jeopardy. Take my advice and put those devices away and out of sight while you are working.

Having access to instant information and news can be seductive. While tempting to be connected, ask yourself if losing your job is worth it. It saddens me to remind everyone that patient information is none of your business if you are not involved in that patient's care. DO NOT go into the chart of anyone unless your job requires you to be there. You are not allowed to look in anyone's chart, including your own. Violating patient privacy is serious and could lead to discipline.

Please be mindful and practice smart judgment while you are working.

And remember this: If you share video or photos of something that happened during work hours, you essentially are leaving digital evidence that you were not working when you were supposed to be.
