## Where's Her Worker's Comp?

*UHP nurse a case study of need for presumption*



**Diane Logan**, one of our nurses in Dermatology, was among four front-line employees who shared their story in a CT AFL-CIO online news briefing May 7. Diane tested positive for COVID-19 in early April. She used all of her sick time to recover and fears a future illness.

"I'm a nurse, I know what this can do to you," she said. "No one knows the damage this does to your lungs or your blood... We want someone to take responsibility because, again, I am positive that I did get the COVID at work."

Thank you, Diane, for your care, and for coming forward to be a voice for the greater effort to establish a worker's comp presumption for front-liners who contract COVID-19 on the job!

The hospital is now talking about our reopening/ramp-up plans. Some of those who were moved from outpatient to inpatient during the crisis are slowly moving back to their home bases. Not all yet, we still have a full ICU as I write this. We get our best information from you. You need to tell us what is going on in your areas. Some management try very hard to just let things slip by. If there is an issue with ramp-up in your area, or the plan does not seem right, contact Jean, Ivonne or myself.

Administrative personnel have reached out to us asking "What about us?" in multiple avenues. From safety issues, to PPE, to re-opening, to telecommuting issues, we are trying to work on these as they come up.

A lot has been going on and a lot of rumors are spreading. We've tried to quell these rumors but we're going to need your help to get the word out.

**Safety:** First, we all have been working hard to keep everyone safe. We at UHP have not lost a member to COVID, but our other locals at AFT have not been as fortunate. There are at least two I know of right now. Other state unions have lost members as well. One of our sister unions has a nurse intubated in the ICU as I write this.

**Evaluations:** Because of social distancing guidelines, we came to an agreement with HR that if an evaluation was an unsat then it had to be done on time to allow us to fight through the process to try to overturn in time for raises in July. If you did not get an evaluation, you have a satisfactory evaluation for the year.

Republican **lawmakers are attacking** us again, with Sen. Len Fasano saying our raises due in July should be taken away. He sent his letter to the governor and made sure he made it public. Remember this is the same guy who says this every year. He says UConn Health Center should never have been built. My happiest day this past month was when I learned he and Themis Klarides were not running again. I'm sure I'll find someone else to fight with at the Capitol.

**July raises:** SEBAC leadership has met once with the Lamont administration on this subject. The request was laughable: "Delay your raise, for essentially nothing." We said no. That's it so far. That's the whole thing. They asked, we said no, not for what you are offering. More meetings will happen. But when there is news to tell everyone we will tell you.

**Hazard pay:** We've received dozens of emails and calls about why we're not getting it, who around us is getting it and how much. We have filed a grievance on this. UConn Health does not want to honor our contract. They believe it says something different. We are fighting them on this issue and will continue to fight for contract language.

**End of legislative session:** The Capitol closed down for end of session, no bad bills, but no gains either this year.

**Public-private partnership:** I've heard nothing on that subject for months. COVID-19 has shown how important it is to have a public health institution, and with our work and partnership with Jackson Labs, we only look better.

I feel like I've covered a lot in a lot of different places, but this is the new normal. We are running around putting out fires. I know you are as well.
