The Janus Watch

As of this writing we're still waiting for the U.S. Supreme Court decision on Janus vs. AFSCME, and it's likely that ruling will have come down

already by the time you're reading this. Please watch for the latest on Janus on our website and the UHP Facebook page. Just as we weren't expecting a favorable outcome, anti-labor forces should not expect the labor movement to simply roll over and die. The labor movement was built long before there was such as a thing as fair-share fees, and has persisted all these years because of its resiliency. The above photo from the MLK Memorial reminds us of this.

Those trying to perpetuate the fallacy of "Right to Work" are counting on a divided house in the labor movement. A divided house is destined to fall on itself, and we can stop that from happening by talking to each other about the benefits of collective bargaining, the power of a united voice, and the understanding that workplace standards raised by union contracts benefit not only union members but all workers.

A strong union with engaged members can withstand Janus and whatever else the "Right to Work for less" crowd throws at us. All we have to do is stay together.

SAG Calculator Due This Month

Representatives from the Office of the State Comptroller expect the updated calculators

expect the updated calculators to purchase years of service in either the State Employees Retirement System (SERS, or defined benefit plan) or the Hybrid Plan to be online at www.osc.ct.gov by June 18. Remember, eligible employees have until Dec. 14, 2018, to transfer from the Alternate Retirement Plan (ARP, or defined contribution) into the Hybrid, and between Sept. 14 and Dec. 14 to convert from ARP to SERS. As more information becomes available, we'll post it on our website at bit.ly/saguhp.

Reminders on Furloughs, Lump Sum

Two things to remember related to the 2017 SEBAC agreement:

- The deadline to use the furlough time is June
 30. Be sure to arrange your furlough time with
 - your supervisor, similar to vacation time.
- Payroll is planning to include both the April (deferred) longevity payment and the \$2,000 (pro-rated) lump sum payment in the check dated July 20. If you are concerned about the tax implications and want to adjust your withholdings, You still have some time to get in touch with a payroll representative and/or Prudential to obtain the necessary paperwork and deadline information.
