PRESIDENT'S CORNER: Fighting for a Seat at the Table

The public-private partnership process is underway and there's not much to report.

We are part of a UConn Health Labor Coalition that collectively is watching developments. What we understand so far is this: Seven proposals came in during the solicitation of interest period; not one at face value was acceptable. Dr. Andy says two of them could lead to something with further discussion, but he has not provided details, and indicated that there likely wouldn't be anything further to report for four to six weeks.

Meantime, what can we do? We can focus on what we can control:

- There's a petition going around that demands labor be a partner in this process. Be sure to sign it and find coworkers to sign it.
- Tell your elected officials your story, how you provide care or support the delivery of care at the state's only public medical center, and how you're proud to do it. Let'em know you're a voter and you're paying attention.
- Look for our "Public Hospital for the Public Good" stickers, be sure to wear'em and share'em.

More to come on this, so keep your eyes and ears open.
