A few things you should know about our contract if you do not already: This is a contract negotiated between UHP and UCH. The mandatory subjects of bargaining include hours, wages (raises) and working conditions. FYI our retirement benefits and pension benefits contract are negotiated through SEBAC

(State Employee Bargaining Agent Coalition) and that contract is good through June 30, 2027.

Throughout the past four years we have faced multiple challenges, the most current COVID 19, which has increased UCH's, and the state's, financial crisis. We have no doubt that these upcoming negotiations are going to be just as tough if not tougher than our last negotiations and we need our collective voice in the room.
