We have two nominees for the vacant position of Vice President, Tier II Employees:



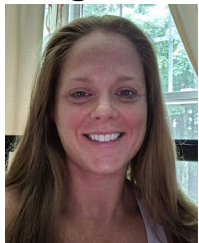
Peter Zarabozo (left) is a staff nurse CN2, UMG Rheumatology.

Arbitrator's Ruling on Hazard Pay

Just as we were about to publish came word that the arbitrator sided with management in our grievance over UConn Health's failure to follow contract language about providing double time to hourly employees who continued to report to work during the pandemic. While disappointing, I can't say it's all that surprising. This is the last step in the grievance process. It's unfortunate, for sure, but we fought for what we thought was right and have no regrets. This is what we do, and we're not going win'em all. You can read the arbitrator's full ruling at bit.ly/2107HazardPay.

Brothers and sisters, our fight for fairness for our members moves forward. The UHP negotiating team is still working to reach a new contract. We (UHP and UConn Health) have signed an **extension agreement for one year** or until we are able to agree to and ratify a new contract. The extension took effect July 1 and does not include raises. All the other areas of the contract stay in place, including sick time, holiday time, vacation, personal time, and ESV/USA scheduling practices. Additionally (and separate from our contract), the job security provision from the SEBAC 2017 agreement expired June 30.

In my 25 years of involvement with UHP, this has been one of the most contentious contract negotiations I can remember.

It is **all of us together**, the membership, that makes the difference. Around 400 people came out for our informational picket and rally May 27, and people noticed. We got our contract extension shortly after that — no coincidence.

We have said all along, this is a two-pronged fight. One is with UConn Health and the second is with our elected officials. **Tuesday, July 13, at 4:30 p.m.** we are joining our fellow state employee unions for a news conference outside the state Capitol — in Gov. Lamont's parking spot — to **demand fair contracts for all state employees**. UConn Health, too many members of the legislature, and the governor himself have decided — *after the year we have all endured* — that there is no money for raises. I do not find this acceptable. Many of you do not either.
